Minutes of Special General Body Meeting

14 August 2019

A Special General Body Meeting of the Mumbai Coin Society was held on 14th August 2019 @5.30pm at Pavilion Hall, P J Hindu Gymkhana, Netaji Subhash Chandra Bose Road, Marine Drive, Mumbai 400002.

Since the requisite quorum was not present the meeting was adjourned for 20 minutes and the same was reconvened @5.50pm, and the members present formed the quorum for the adjourned meeting.

- 1. A total of 42 Life Members of the MCS including members of the MC signed the Register of Attendance to mark their presence.
- 2. Hon. President Shri Farokh S. Todywalla chaired the SGBM.
- The Hon. Secretary Shri Kaizad F. Todywalla started by reading the Notice to the SGBM on the floor for the benefit of all present.
- 4. Thereafter item #1 on the agenda was taken up for consideration and approval. The Hon. Secretary read the relevant clause 7 from the "Rules & Regulations" of the Mumbai Coin Society and explained the proposed amendment.
- Thereafter members present were invited to raise any queries they may have or any suggestions or observations with regards to the proposed amendment at item #1 in the Agenda. None was forthcoming.
- 6. The Hon. Secretary then invited members to vote in favour of the said amendment by show of hands. All members present voted in favour of the proposed amendment at item #1 in the Agenda. Members not in favour of the said amendment were asked to vote against the said amendment by show of hands. None were forthcoming and the proposed amendment at item #1 in the Agenda was approved unanimously.

- 8. Thereafter item #2 on the agenda was taken up for consideration and approval. The Hon. Secretary read the relevant clause 28 from the "Rules & Regulations" of the Mumbai Coin Society and explained the proposed amendment.
- 9. Thereafter members present were invited to raise any queries they may have or any suggestions or observations with regards to the proposed amendment at item #2 in the Agenda. None was forthcoming.
- 10. The Hon. Secretary then invited members to vote in favour of the said amendment by show of hands. All members present voted in favour of the proposed amendment at item #2 in the Agenda. Members not in favour of the said amendment were asked to vote against the said amendment by show of hands. None were forthcoming and the proposed amendment at item #2 in the Agenda was approved unanimously.

11. Hence with regards to the proposed amendment to the "Rules & Regulations" of the Mumbai Coin Society with respect to:

- 12. Thereafter item #3 on the agenda was taken up for consideration and approval. The Hon. Secretary read the relevant clause 9 from the "Rules & Regulations" of the Mumbai Coin Society and the proposed addition to the said clause 9 and explained the proposed amendment.
- 13. Thereafter members present were invited to raise any queries they may have or any suggestions or observations with regards to the proposed amendment at item #3 in the Agenda.
- 14. Shri. Ajay Goyal raised the point that the a minimum quorum should be mandated for any kind of General Body Meeting to able to pass any amendments to the "Rules & Regulations" of the Mumbai Coin Society. He proposed the said minimum number to be 20 members.
- 15. However, Shri Kaizad F. Todywalla put forth the suggestion that whatever be the mandated minimum quorum for any kind of General Body Meeting to able to pass any amendments to the "Rules & Regulations" of the Mumbai Coin Society, that minimum number should be exclusive of members of the Managing Committee present for such a meeting and their presence should not be counted towards the minimum mandated quorum of life members needed.
- 16. Shri Sanjay Gosalia and Shri Upendra Salve proposed such mandated minimum quorum to be of 15 Life Members exclusive of the members of the Managing Committee present for such a meeting.
- 17. Since there was no unanimous agreement to the mandated minimum quorum of Life Members exclusive of the members of the Managing Committee to pass any amendments to the "Rules & Regulations" of the Mumbai Coin Society (said quorum) the same was put to vote by show of hands and an overwhelming majority of members present voted in favor of 20 as opposed to 15 as the said quorum.
- 18. The Hon. Secretary then invited members to vote in favour of the said amendment by show of hands. All members present voted in favour of the proposed amendment at item #3 in the Agenda with further addition as mentioned in 17 herein above. Members not in favour of the said amendment were asked to vote against the said amendment by show of hands. None were forthcoming and the proposed amendment at item #3 in the Agenda with further addition as approved in no 17 herin above was approved unanimously.

19. Hence with regards to the proposed amendment to the "Rules & Regulations" of the Mumbai Coin Society with respect to clause 9 as under:

Proposed Amendment

To add: If the required quorum is not present then the meeting may be adjourned for the period of time the Notice to said meeting may indicate, or for 15 minutes or any such reasonable time the Chair may deem fit and the members present shall form the quorum for such adjourned meeting.

Approved Amendment

To add: If the required quorum is not present then the meeting may be adjourned for the period of time the Notice to said meeting may indicate, or for 15 minutes or any such reasonable time the Chair may deem fit and the members present shall form the quorum for such adjourned meeting. However, a minimum quorum of 20 Life Members not including members of the Managing Committee present for such a meeting, will be required to pass any amendments to the "Rules & Regulations" of the Mumbai Coin Society.
